This privacy notice will give you information on how PIL collects and processes your personal data through your use of this website, including any data you may provide through this website or use any of the PIL platforms, apps, and/or online portals ("Platforms").

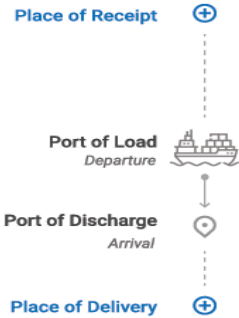

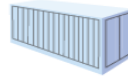

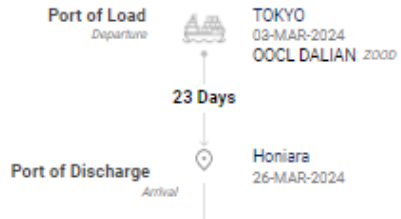
